

WATER MAIN REPLACEMENT PROGRAM DETAILS ON YOUR NEIGHBORHOOD PROJECT IN THE 33RD WARD

NPL Construction Co. (NPL) has been contracted to serve your community as part of the City of Chicago's Water Main Replacement Program.

In the 33rd Ward we will be replacing mains on these streets:

1. N. Manor Ave. from W. Leland Ave. to W. Sunnyside Ave.
2. N. Francisco Ave. from N. Manor Ave. to W. Eastwood Ave.
3. W. Wilson Ave. from N. Manor Ave. to N. Branch Chicago River
4. W. Eastwood Ave. from N. Manor Ave. to N. Branch Chicago River
5. N. California Ave. from N. Manor Ave. to W. Montrose Ave.

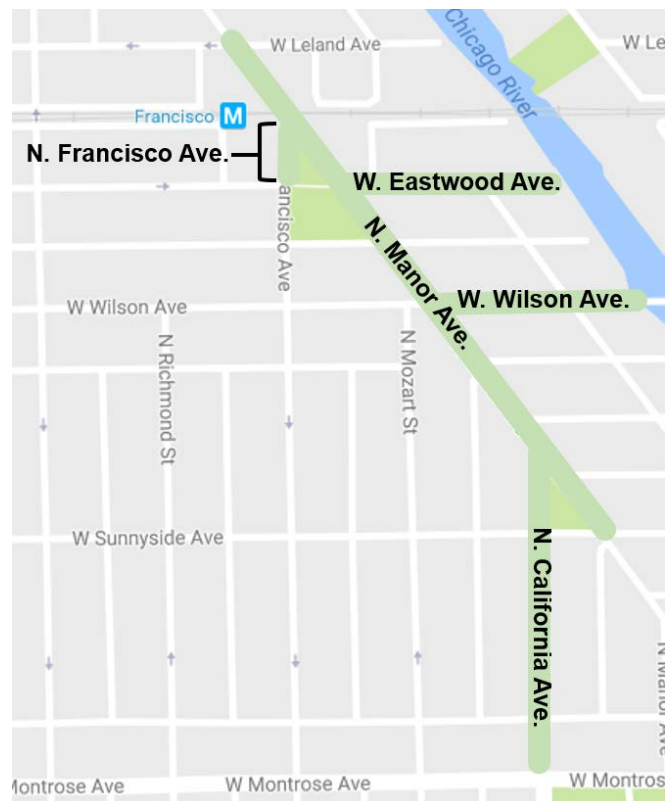
This work will install new mains approximately five feet beneath the surface, along with new fire hydrants. There will be periodic street closures and coordinated water shutoffs before work is finished and streets are restored.

Direction of Work

Work will begin on N. Manor Ave., move west to N. Francisco Ave. and east to W. Wilson Ave. and W. Eastwood Ave. Work will move to N. California Ave.

Updates

NPL will be working in conjunction with the Department of Water Management and the 33rd Ward Office for updates to the project as milestones are completed. WATER MAIN REPLACEMENT PROGRAM

WHAT YOU NEED TO KNOW

The City of Chicago Department of Water Management (DWM) is currently engaged in a mayoral initiative to replace all of the 100-year old water mains. When completed, this process will make water service more reliable for residents, businesses and fire protection while reducing the need for costly and inconvenient repairs.

NPL Construction Co. (NPL) has been contracted by the City of Chicago to install new water mains in your neighborhood. While there may be some inconvenience and street disruptions, we will strive to make sure you know about each step and ensure you can reach us with any concerns.

When Work Begins

- NPL will work with your alderman to identify any special needs and concerns in each neighborhood before work starts.
- Throughout the City, water mains run about five feet below the surface of the street, so sections of the street will be opened up for new mains to be installed.
- Water will be turned off to transfer your water service to the new main. **NPL will provide you with 72 hours advance notice before water shutoff.**
- New fire hydrants will also be installed in the process.
- Streets and curbs will be restored to full working order, if damaged during construction.
- NPL will post “NO PARKING” signs during work hours and traffic will be limited during those times (generally 7 a.m. - 4 p.m.) **NPL will provide 48 hours advance notice before water shutoff.**
- NPL will strive to ensure that you will always be able to get to your home or business.

Stay Informed

All vehicles and personnel working on replacing the mains will be marked with the NPL logo.
